






"It is estimated that 1 in 5 women live with a disability;



in fact, the prevalence for disability is higher in women tan in men (19,2% vs 12%).









Contributing factors include the lower economic and social status of women and girls, gender-based violence and harmful and discriminatory practices on the basis of gender."












Ana Peláez Narváez was born in Spain in 1966 and she has been blind since birth.

She is currently the Executive Advisor of International Affairs and Foreign Expansion for the Spanish National Organization of the Blind (ONCE),




Executive Vice-President of the CERMI Women Foundation, and Vice-President of the European Disability Forum (EDF), which she chairs its Women Committee.




She was a member of the UN CRPD Committee since 2009 to 2016 and member of the Executive Committee of the European Women's Lobby since 2010 to 2014.




Ana's working languages are French, English and Spanish.









She fights for the rights of women and girls with disabilities in Spain, Europe and all around the world.







Since 2010, she has participated as the representative of women with disabilities from Spain and from Europe in the UN Commission on the Status of Women.









Women and girls with disabilities are still outside of the decision-making process and the work on gender equality, which means that often their needs and voices are leaving unheard.










It is time to incorporate disability in the CEDAW and to stop this invisibility they suffer.







"I also want to focus on strengthening the work of CEDAW Committee, in relation to the multiple discrimination suffered by many women that are invisible for society."









"This requires further advances in the elaboration of guidelines addressed to the States Parties in relation to addressing intersectional discrimination, in order to guarantee that no one is left behind."









